Post-consultation work

Main changes to the HAR Main Body

Inclusion of FTRobligations

- Definition added
- Removing distinctions between FTR-options and FTR-obligations
- No intention to introduce FTRobligations at this stage
- If necessary in the future, specific provisions to be introduced in a relevant Annex

Compensation for curtailments

- Curtailments to ensure operational security before the day-ahead firmness deadline
- The application of a cap is optional (as stated in the FCA)
- The application (or not) of a cap is subject to the approval of the relevant NRAs

Consistency points

- Removing terms already defined in the FCA Regulation
- Similar format to other all TSOs' deliverables (e.g. for CACM)
- Day-ahead firmness deadline: 60 minutes reference to the dayahead firmness deadline proposal under CACM
